

CERTIFY YOUR DISC JOCKEY – NETWORK ADDENDUM

This Addendum forms part of the agreement between _____ (herein DJ) and _____ (herein "Client") dated the ____ day of _____, 20__, herein the Agreement.

WHEREAS the parties hereto agree and accept to the terms set out below which constitute the standards terms required to fulfill the standards of **certifying a DJ** for purposes of Certify Your Disc Jockey - Network (CDJ);

AND WHEREAS the Client has engaged the DJ to provide DJ services pursuant to an Event as defined in the Agreement;

NOW THEREFORE for \$1.00 and other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged the parties hereto agree as follows:

1. DJ shall comply with the following standards set out below in paragraph 1-10 inclusive:
 1. Respond to Client enquiries within agreed upon time frames and in a timely manner;
 2. Use a professional sound system and series equipment that is suited to the Event;
 3. Bring backup equipment to the Event to ensure minimal down time in case of equipment failure (not a call away);
 4. Use licensed music for public performance (i.e. AVLA licensed or record company/ artist compensated) at the event;
 5. Be insured against liability and prove it, when requested by Client;
 6. Have a minimum of three years professional wedding DJ and Emcee experience, and be able to prove it to Client's satisfaction;
 7. Maintain a business website with up-to-date contact information;
 8. Fully disclose all expenses. You will not face additional expenses or charges for services other than those clearly defined within the written contract;
 9. Never drink alcohol while at the Event;
 10. The DJ you meet with is the DJ who will perform at the Event.
2. If the DJ does not meet the standards in paragraph 1, 1-10 inclusive above, the full amount of liability to which he or she may be subject is the amount contracted for services as the DJ regarding the Event.
3. Unless a written notice outlining the terms of any complaint is sent to the DJ within 7 days of the Event the DJ will have been deemed to have fulfilled the terms of this Agreement to the Client's satisfaction and the client thereby is deemed to have certified the DJ having met the standards herein.
4. This Addendum and the Agreement is the entire agreement between the parties with respect to the subject matter contained therein and herein and it shall not be amended except by an instrument in writing signed by all of the parties hereto and shall be binding upon the respective heirs, executors, administrators, assigns and the directors and officers of the parties hereto.
5. The terms of this Addendum are in addition to, not in conflict or derogation of the terms of the Agreement. The terms of this Addendum shall have the same meaning as they have as set out in the Agreement.
6. The parties hereto acknowledge the terms of the Agreement are in full force and effect and shall do commit no act or omission which may breach or cause the breach of the terms of the Agreement.
